**Long Beach Pimp Sentenced to Prison for
Human Trafficking, Rape, Other Crimes**

A Long Beach man convicted of pimping two women and sexually assaulting one of them was sentenced today to 47 years and four months to life in state prison, the Los Angeles County District Attorney's Office announced.

Last month, a jury found Lebrette Stacey Winn, 23, guilty of two counts of pimping, two counts of pandering by procuring, and one count each of human trafficking to commit another crime, sodomy by use of force, forcible rape, aggravated mayhem and kidnapping in case NA095730.

At today's sentencing, Los Angeles County Superior Court Judge Tomson Ong also ordered Winn to register as a sex offender for life and pay a \$10,000 fine. Additionally, the defendant was ordered to stay away from the two victims for 10 years.

Winn's co-defendant, Eric James Avery, 25, is scheduled to be sentenced Oct. 17 at the Los Angeles County Superior Court, Long Beach Branch in Department S19. Avery was convicted on Aug. 11 of two felony counts: pimping a minor 16 years of age or older and human trafficking of a minor for a sex act. Furthermore, jurors found true a gang allegation for Avery.

Deputy District Attorney Lee Ashley Cernok, who prosecuted the case, said on May 15, 2013, two female victims, ages 20 and 18, escaped a locked car in Culver City. They ran to a good Samaritan and told him they had been kidnapped and forced into prostitution. The man drove them to a nearby police station and authorities began an investigation.

The 20-year-old victim told police she met Winn in January 2013. At the time, the defendant convinced the woman to work as a prostitute and then he raped her.

The prosecutor said although the woman tried working as a prostitute, she ultimately ran away. Winn later found the woman and forced her back into the sex trade, all the while physically and sexually assaulting her.

Ultimately, Winn had his pimp moniker and a dollar sign tattooed on the victim's forehead as punishment for her wanting to go home. Moreover, he wanted to show she was his property, the prosecutor said.

The 18-year-old victim told authorities that she met Winn in November 2012 and he also persuaded her to prostitute for him, but she eventually stopped.

On May 15, 2013, defendant Winn created a ruse for the 18-year-old to meet with him, at which point he forced her into his car and threatened her. Winn then picked up the 20-year-old victim and took both women to the mall. While he was inside, both women escaped from the vehicle.

A day after the two victims went to police, law enforcement arrested Winn while he was driving to meet the victim. Police pulled him over and arrested him. Co-defendant Avery was the passenger in the vehicle and also was taken into custody.

Officers found a hotel key in Avery's pocket, the prosecutor said. When they went to the hotel room, they discovered a 16-year-old girl who revealed she had been working as a prostitute for Avery.

The case was investigated by the Long Beach Police Department's Vice Investigations Section, Sex Crimes Detail, Missing Persons Detail, and Gang Enforcement Division.
