## **Four-Member "Knock-Knock" Burglary Crew Sentenced**

Two men and two women have received state prison sentences after pleading no contest yesterday to breaking into a Pacific Palisades home, the Los Angeles County District Attorney's Office announced today.

Donte Lamont Caldwell (dob 7/1/92) was sentenced to 18 years in state prison, Elanee Marie Jarrett (dob 8/31/94) received 10 years, Everald Martin Fisher Jr. (dob 1/19/93) was sentenced to nine years in state prison and Chivetta Lanae Overstreet (dob 8/3/93) was sentenced to five years in prison.

Deputy District Attorney Harden Sooper said all four pleaded open to the court to one count each of first-degree residential burglary and grand theft of personal property, jewelry and purses, in case SA090598.

An open plea is one made to the court when there has been no plea agreement.

Additionally, Caldwell and Jarrett admitted prior burglary convictions and Fisher admitted a prior robbery conviction. Overstreet admitted prior convictions for having a concealed firearm in a vehicle and possession of a firearm by a felon.

On June 8, 2015, members of the Los Angeles County Sheriff's Department Major Crime Bureau Burglary Task Force observed Caldwell driving with the defendants in a rented Toyota while casing homes in the Pacific Palisades area, the prosecutor said. When Caldwell parked at a house in the 800 block of Orea Place, Jarrett knocked on the door then jumped over a gate and entered the residence through the side of the house, according to evidence presented in court.

Fisher also jumped over the fence and both he and Jarrett emerged with the victims' property, the prosecutor added. According to court testimony, during the burglary, Overstreet remained in the rear seat of the car with a police scanner and once arrested was found wearing the victim's gold bracelet.

Fisher also pleaded no contest yesterday to a separate 2015 first-degree residential burglary in case SA090907. Overstreet still faces residential burglary charges in case BA446397.
